# SOUTH CENTRAL ATHLETIC CONFERENCE

# **CONSTITUTION**

#### **ARTICLE I**

#### **NAME**

The name of this organization shall be the South Central Athletic Conference.

#### **ARTICLE II**

# **PURPOSE**

The purpose of this organization shall be to unite member schools in athletic competition for the betterment of the athletic program in all sports, and to have mutual understandings of all member schools for the improvement of relationships between the member schools.

#### **ARTICLE III**

# **MEMBERSHIP**

# Section 1: Member Schools

The members of the South Central Athletic Conference as formed by action of the member schools on June 20, 2020, shall be; Cle Elum/Roslyn (Tennis Only), College Place, Columbia-Burbank (Tennis Only), Connell, Granger (Boys Soccer and Tennis Only), Highland (Boys Soccer and Tennis Only), Kiona-Benton City, Mabton (Boys Soccer only), La Salle, Naches Valley, Royal, Toppenish, Wahluke, Wapato, Warden (Boys Soccer Only), White Swan (Tennis Only), Zillah.

# Section 2: Future Members

In the future, schools within WIAA District 5, which do not have appropriate competition available to them, may petition the conference for membership. Schools are voted in by a two-thirds vote of existing member schools or when YVIAA action places them in the Conference.

#### Section 3: Dues

An annual assessment may be charged to each member school for the purpose of financing the various conference - sponsored activities; the amount to be determined annually.

# Section 4: Sports Commitment

As members of the South Central Athletic Conference, schools are expected to compete in conference athletic schedules drawn annually. Commitments are made each spring for the following school year.

# **Section 5: Scheduled Activities**

The Conference will develop standard operating procedures for the following activities: Football, Volleyball, Cross Country, Wrestling, Basketball, Golf, Fastpitch Softball, Baseball, Track, Tennis, Soccer, and Cheerleading

#### ARTICLE IV

#### **MANAGEMENT & OFFICERS**

# Section 1: Management

The management of this organization shall be vested in the officers elected by member schools at a regularly scheduled meeting as described in Article V.

#### Section 2: Officers

The officers of the South Central Athletic Conference shall consist of: President, Vice President, Secretary, Treasurer, Technology/SOP Representative, and three YVIAA representatives.

- A. Duties of the President: The president shall be a principal or athletic director of a member school. The term of office shall be for one year. He/She shall be responsible for those duties that ordinarily evolve upon the president.
- B. Duties of the Vice President: The Vice President shall be a principal or athletic director of a member school. He/She shall perform the duties of the president in his/her absence, serve as the conference representative to any inter-conference meetings and perform such other duties as are generally associated with the office or assigned by the president as needed. VP is also responsible for league trophies and awards. Term of office is one year.
- C. Duties of the Secretary: The secretary shall be a principal or athletic director of a member school. The secretary shall work with the president to create agendas and keep the minutes of all conference meetings, handle all official correspondence, maintain an attendance record by school name, and keep a digital shared file of all official conference business and correspondence. Term of office is one year.
- D. Duties of the Treasurer: The treasurer shall be a principal or athletic director of a member school. The treasurer shall have charge of all conference monies, pay all Conference bills when authorized by the Conference, and shall maintain an accurate record of all such funds and expenditures. The treasurer shall have the Conference funds audited as needed. Term of office is one year.
- E. Duties of the SOP/Technology Representative: Keep SOP's updated annually and make changes in accordance with league approval. Support AD's with technology needed for the SCAC such as Arbiter and WPA League Accounts, Dropbox(or applicable digital shared files), and other technological needs.
- F. YVIAA Representatives: The YVIAA representatives shall attend the meetings of the YVIAA executive board as called by the board secretary. He/She shall report monthly to the Conference on activities of the YVIAA and represent the concerns and interests of the Conference to the YVIAA. Recommend one representative from the East and one from the West.
- G. Sports Activities Representatives: Keep league SOP's current and viable, act as liaison with the League, YVIAA, WIAA and WOA, and coordinate all post-season play.

#### Section 3: Conference Schedules

All Conference schedules are to be approved by a quorum (one more than half) of the Conference members at a regular meeting. On the league master schedule (per sport) all varsity league contests will be counted as varsity competition and count towards the allowable maximum number of contests. Except for mutually acceptable changes by member schools, official conference schedules are binding upon member schools. If, for reasons beyond the control of the schools involved, a contest must be canceled, it is to be either (a) rescheduled for a mutually acceptable date and place or (b) forfeited by the canceling school. Divisional play will take precedence over all other contests.

- A. Conference schedules will be developed, wherever possible, on a two-year basis.
- B. Transportation and time missed from school shall be considered in all conference schedule developments and an emphasis placed on minimizing the time lost from school and conserving transportation requirements.
- C. Unless mutually acceptable to the teams involved, a conference-scheduled contest will take precedence over non-conference events for member schools.
- D. In the event a scheduled conference contest must be postponed or canceled due to circumstances beyond the control of either participating school, every effort will be made to have direct communications between the administrators or athletic directors of the schools and reschedule the event as quickly as possible.

# Section 4: Conference Play-offs

- A. A play-off plan will be developed by the conference and adopted for all sports. Whenever applicable or possible, the District Playoff Sites should rotate each <u>calendar year</u> between the East (odd years) and West (even years).
- B. Whenever a play-off is necessary, the date and site will be set by conference vote. Whenever possible, conference sites will be used for all play-offs and qualifying tournaments, where such a site and community exists that can properly house the event and is reasonably located to the participants.
- C. Receipts from SCAC funds may be made to member schools only upon action approved by the member schools at a regular meeting. Such action is valid with a majority vote of the members present only if a quorum exists as defined in Article VI.

# **ELECTIONS**

Election of the officers shall be held during the March or April meeting. A quorum of members must be present to validate such an election. New officers assume duty at the AD meeting following the Spring YVIAA meeting. All officers shall be elected annually. There shall be no limit on the number of terms that may be served in office. The officers shall be nominated from the floor.

# **ARTICLE VI**

# **LEAGUE AD MEETINGS**

# Section 1: Meeting Attendance

AD's from each school must attend SCAC League AD Meetings. When attendance is not possible in person, by phone or video, schools must send a representative. Notification in advance to the league president should be made whenever possible.

#### Section 2: Guest Attendees for Meeting

Any guests attending SCAC League AD Meetings must be communicated and approved through the Vice President and President prior to the meeting.

#### Section 3: Meeting Minutes and Reporting

League meeting minutes will be recorded during League AD Meetings. At the conclusion of each meeting, the meeting minutes will be reviewed and approved by the voting members of the league. The approved minutes will be sent and digitally uploaded to AD's within 24 hrs of the meetings conclusion.

# **ARTICLE VII**

# **VOTING**

# Section 1: Parliamentary Procedures

Except as listed in this Article, voting on all business shall follow the guidelines of Roberts Rules of Order with a quorum needed to conduct business and a majority vote needed to carry general motions. A quorum shall exist when one more than half of the member schools are officially represented at a regular or special meeting.

# Section 2: One-School/One-Vote

For the purposes of voting on all business of the South Central Athletic Conference, each member school may cast only one vote. When the president is the only representative of his/her school, the president will be allowed to cast the vote for his/her school.

# Section 3: Tie Votes and Vote Recording

A tied vote defeats the issue in question. AD's may request a roll call vote, with approval from league officers. \*A roll call vote for action taken against another school is required.

#### **ARTICLE VIII**

#### **DISPUTES**

# Section 1: Procedures

When disputes arise between schools, the parties involved should make every effort to resolve the problem between them. If the problem cannot be solved, the schools involved should submit the problem to the Conference. The League president will defer to the Appeals, Ejections, and Protest Committee. The committee will be composed of at least two neutral members. The Conference's decision is binding on all parties to the dispute, pending appeal to the YVIAA Executive Board. The results will be share with all league Athletic Directors.

#### Section 2: Appeals

If any school wishes to appeal a decision to the South Central Athletic Conference, the principal of such school must:

- A. Notify the Conference president in writing that they wish to appeal the decision.
- B. Notify the YVIAA Board that they wish to appeal the decision of the South Central Athletic Conference.
- C. Provide the YVIAA Board with complete typed details of the problems, signed by the school principal.
- D. Request that the Conference president or secretary provide the YVIAA with all details of the problem along with the Conference's rationale for the decision that was handed down by the Conference.

# Section 3: Final Appeal

The decision of the YVIAA Board may be appealed to the WIAA Board, under Article 30.1.0 of the WIAA constitution.

#### ARTICLE IX

# **EJECTIONS**

Follow the WIAA ejection procedure as listed in the WIAA Handbook.

#### ARTICLE X

#### AMENDING PROCEDURES

# Section 1: Amendments

The Constitution and By-Laws of the South Central Athletic Conference may be amended by a majority vote of the membership of the Conference.

#### Section 2: Procedure

Schools wishing to submit an amendment for consideration by the Conference must submit the proposal, verbally or in writing, to the members prior to asking for a vote on the amendment.

# Section 3: Operating Procedures

Review of Constitution, By-Laws, and Amendments will take place in the spring. Revision of Standard Operating Procedures will take place during the spring SOP Meeting, or as necessary throughout the year.

#### SOUTH CENTRAL ATHLETIC CONFERENCE

#### **BY-LAWS**

# Section 1: Standard Operating Procedures

Standard Operating Procedures (SOP's) will be developed and reviewed annually by the membership of the South Central Athletic Conference according to Article IX.

# Section 2: General Operating Guidelines

Except as amended by specific regulations in a particular sport SOP the following guidelines shall regulate sports activities within South Central Athletic Conference. Members shall adhere to these regulations during the conduct of all events. Warnings, probations, loss of reimbursement revenues, and expulsions from the conference will all include correspondence to: School Boards, Superintendents, Principals, and Athletic Directors.

# **ADMISSION PRICES - ALL SPORTS**

The admission prices for South Central Athletic Conference events will be determined annually by vote of the members in a general meeting. The only sports admission may be charged are: football, volleyball, basketball, soccer and wrestling.

#### **ASB CARDS**

Each school in the conference will honor ASB cards from other member schools for reduced admission prices. Students are required to present their ASB card at the gate to obtain such reduced price consideration.

# **CONFERENCE TROPHIES**

As the YVIAA District 5 Board gives conference trophies. We will follow their guidelines in our awards. To receive a conference trophy, participation in the conference schedule is mandatory.

# **SUPERVISORY PASSES**

Each of the Conference's member school boards agree to honor conference passes for personnel whose responsibility it is to supervise students attending the event and for those who are acting as an athletic scout for their school. Annually each school will be issued supervisory identification cards. Supervisors must show ID card and sign in stating their duties at the gate. The number of passes will be determined annually by vote of the conference members.

#### **FORFEITS**

- A. If a team is unable to complete a season, all played conference games will count in league standings. Any un-played conference games will count as forfeits. Games may only be re-scheduled by athletic directors for school-related activities, acts of nature, facility conflicts, security issues, and other extenuating circumstances that are mutually agreed upon. Teams may not re-schedule contests based on ineligibility of participants.
- B. A league school counts for league standings if they complete more than 50% of their league season. Example: Team A completed 4 of 10 league contests. Since they did not complete more than 50% of the league season this gave the West 5 teams and the East 7 teams. The 4/5 crossover game will be played. If Team A had completed at least 6 of the 10 league contests then the West would have had 6 schools and the East 7 schools, and the 4/5 game would not be necessary.

# TIMES AND SITES

The starting times established in the SOP's shall be followed in the conduct of all conference events. Times may be changed only by mutual consent of the athletic directors of the schools involved.

#### Section 3: Amendments

Only the same process set forth in Article VIII of the Constitution of the South Central Athletic Conference may amend these By-Laws of the South Central Athletic Conference.

#### LEAGUE AUTHORITY/ACTIONS

The League has the authority to investigate and take action if a school exhibits or is accused of harassing or discriminatory remarks, actions or gestures. The actions shall be addressed and voted upon by the SCAC AD's.

# ALL LEAGUE SELECTIONS

Most programs will conduct a coaches' meeting after their last regular season game to determine the All-League teams. All league recognition for traditional individual programs (e.g. Track, wrestling, golf, etc.) will be determined by order of finish at the sub and/or district events (see below). Players will receive All-League certificates for being named to the 1<sup>st</sup>, 2<sup>nd</sup> and Honorable Mention teams. For sports that are a single league, a third all-league team may be added. There will be one (1) additional member for each team beyond the actual number of players who play at one time on a given traditional team sport. A suggested format for voting for all sports is explained in the next section entitled "All-League Voting Format", and the number of players to be named to the All-League teams is also defined in that section. The Player of the Year will be selected by the coaches at the all-league meeting. At most there may be co-MVP's (2). The host Athletic Director will provide the results of the all-league teams to the league Athletic Directors within three (3) business days after their meeting for proof of correct spelling and grade in school. The host Athletic Director will then report the all-league results to the respective media for publishing.

#### ALL-LEAGUE VOTING FORMAT

The following procedure for the selection of the all-league teams is suggested. However, by majority approval from the coaches of their respective program (e.g. volleyball, basketball, etc.), the coaches may conduct a process different than the suggested process. \*Online voting may be used with league approval.

Coaches are encouraged to put together a packet of information on the players they plan on nominating at the all-league meeting. This packet of information may include statistics and other pertinent information that will help them explain their value to their team.

The host Athletic Director (or designee) will start the meeting by asking the coaches to nominate players from their own team who they believe are potential 1<sup>st</sup> Team All-League players. The host Athletic Director (or designee) will write those players' names and year in school on a white board under the name of the school for whom the athletes play. Then, coaches will vote for 1<sup>st</sup> Team by either verbal or written ballot

(the written ballot must display the name of the school voting). The number of votes will be equal to the number of selected members of each team (1st and 2nd) as defined below. **Coaches may not vote for their own players.** Coaches hand in their vote sheets (or verbally announce their selection) to the host Athletic Director (or designee) has all the vote sheets (or verbal selections), s/he puts a tally mark next to the names on the board for each vote that the player receives. Once all tallies have been put on the board, the host Athletic Director (or designee) adds them up. The 1st team all-league will be filled by the player with the most tallies, followed by the next most, and so on down the line until the 1st team is complete (as per guidelines below). If a tie exists for the final spot(s), the host Athletic Director (or designee) will conduct a re-vote to break the tie. If a tie remains after three (3) attempts, the player from the higher grade (e.g. 12th grade, 11th grade, etc.) will be placed on the 1st team. If they players are in the same grade, the player whose team finished higher in the league standings will be placed on the 1st team. The re-vote will consist of ballots by those teams that do not have a player tied for that final spot(s). The host Athletic Director (or designee) will ask someone who can print neatly to write those names down on a sheet of paper with the heading, "First-Team All-League at the top. Coaches are required to give first name, last name, school, and year in school, and check for correct spelling.

Next, the host Athletic Director (or designee) will erase the names of the players who were chosen to the First Team, leaving the other names on the board as potential 2<sup>nd</sup> Team All-League players. Coaches will

then nominate additional players for the 2<sup>nd</sup> team, and voting will take place like it did for the 1<sup>st</sup> Team. If a tie exists for the final spot(s), the host Athletic Director (or designee) will conduct a tie breaking process as defined earlier (as done for 1<sup>st</sup> team). At the conclusion of the voting, each coach (in team sports - football, volleyball soccer, basketball, baseball and softball) will have the opportunity (option) to select one deserving player to be placed on the Honorable Mention team.

After the teams have been selected, coaches will vote for a "Player of the Year" and a "Coach of the Year." The Player of the Year or Co-Players of the Year must come from listed players selected to the 1st Team. For football, a lineman of the year will also be recognized and follow the player of the year voting procedures. Each coach writes down who s/he feels should be the Player of the Year and the Coach of the Year on a ballot (or verbal vote) and hand their ballot to the host Athletic Director (or designee). Written ballots must list the name of the school voting. The host Athletic Director (or designee) reads the votes to the group and puts tally marks next to the names on the board for each vote that the player receives. **Ties are allowed for Player of the Year, but not for Coach of the Year.** If a tie exists for Coach of the Year, the host Athletic Director (or designee) will call for a re-vote. Those coaches that are involved in the tie will not be allowed to vote. If a tie remains after three attempts at voting for Coach of the Year, the coach of the team that finished higher in league play, will be declared as Coach of the Year. The league will purchase a plaque for the Coach of the Year recipient. \*If only one coach remains to vote to break a tie, skip to better record in league play to determine coach of the year.

#### **COACH OF THE YEAR**

Each sport (male & female) will select <u>one</u> Coach of the Year. There will be no ties in the Coach of the Year voting. The league will purchase a plaque for Coach of the Year recipient.

# HOST SCHOOL GUIDELINES

The following procedures are to be followed by all member schools of the South Central Athletic Conference. The emphasis of the Conference is for the home school to act as hosts and visiting school to act as guests.

- A. The host school should have a representative who identifies himself/herself to visiting coaches and/or student supervisors. Visiting coaches and/or supervisors should seek out host school representatives and introduce themselves.
- B. Separate cheering sections should be provided for visiting schools when possible. Schools may allow continuous standing for indoor events in a designated standing section only. The host school should provide direct and close proximal supervision of the student section.
- C. Host schools should consider the location of the home and away student sections and make every effort to align or match locations of their schools bench or team location to the degree possible. In Basketball it is preferred that the home student section is located near the home team second half hoop/goal. During competition, indoor student sections must be limited to the first row of the bleachers or above, not in contact with the floor or court where applicable.
- D. The host school representative will make sure locker rooms are open and clean for visiting school teams. Supervision of student behavior in locker rooms is the responsibility of the visiting team coach. Visiting team schools will be responsible for any damage or vandalism to host school locker rooms. The host school shall provide a key, upon request, for use by visiting coaches or make appropriate arrangements for locking visiting team lockers. Each school will provide at least one locker room for the visiting teams. In basketball it may be the same locker room for boys and girls.
- E. The host school should make certain that playing and operational conditions are available and equal for both schools including areas to film, if any, for both schools and areas to spot, if any, for both schools.
- F. Each school is responsible for its own communications system whether home or away.
- G. Mascots may be used at home events only. Mascots will be limited to one official mascot. No live animals will be permitted as mascots. Mascots may attend the post-season.
- H. AD's are responsible to update rosters for team sports by the first contest online using the applicable network.
- I. Preferred that the traveling school provides supervision of their own crowds during post season play. AD's should communicate in advance regarding post season supervision needs.
- J. Host school is responsible for the emergency service plan.

The spirit of the SCAC should be to create a healthy atmosphere for athletic competition such that the opportunities are equal for all. To this end, it is the desire of the conference that young men and women will be afforded the opportunity to take part in a positive, competitive, interscholastic experience.

# SOUTH CENTRAL ATHLETIC CONFERENCE

# **PLAY-OFFS**

# Section 1: General Guidelines

The purpose of this section is to provide a standard guide for the resolution of tie situations within the South Central Athletic Conference. Except as specifically referenced within the SOP for an individual sport, this section shall be binding upon the member schools for the resolution of tie situations at the conclusion of season play within any given sport.

- A. In all tie situations the winner of the head to head conference competition will determine placement or elimination. To use head to head as a criteria in multi-tie situations, one team must have swept all other teams in the tie. For seeding purposes in multi-tie situations, team records against the other teams involved in the tie will be the first criteria for placing, followed by the number draw.
- B. All play-off games will be held at a neutral conference site when at all possible.
- C. Number Draws for tie situations will be at the first conference meeting of the current sports season.

D. If a tie still exists the following guidelines will be followed:

# TWO WAY TIE

- 1. <u>No one out of the tournament</u>: Team drawing the lowest number gets the highest seed into the tournament. No play-off.
- 2. One team out of the tournament: The two teams play for the open spot in the tournament.

# THREE WAY TIE

- 1. <u>No one out of the tournament:</u> Team drawing the lowest number gets the highest seed into the tournament and so on. No play-off.
- 2. One team out of the tournament: Number 1 and Number 2 (best number draw) will play in the first playoff game. The winner of the first play-off contest qualifies for district. The loser of the first play-off contest would then play the Number 3 team for the final district spot. The winner of the first playoff game gets the higher seed into districts.
- 3. <u>Two teams out of the tournament</u>: Lowest number gets the Bye and the other two teams play. The winner then plays the Bye for the spot into the tournament.

# **FOUR WAY TIE**

- 1. <u>Three places into tournament:</u> Number 1 and Number 2 (best number draw) play for the highest seed. Number 3 and Number 4 play for the next highest seed into the tournament. The two losers play for the remaining seed.
- 2. <u>Two places into tournament:</u> Number 1 and Number 2 (best number draw) play for one seed in the tournament and Number 3 and Number 4 play for one seed in the tournament. Seeding is first determined by head to head and then by lowest number draw.
- 3. One place into tournament: Number 1 and Number 2 (best number draw) play and Number 3 and Number 4 play losers out. Winners play for the place in the tournament.

#### FIVE WAY TIE

- 1. <u>Three places into tournament:</u> Number 1 gets the Bye and last spot into tournament. Number 2 and Number 3 play for the highest seed and Number 4 and Number 5 play for the next highest seed.
- 2. <u>Two places into tournament</u>: Number 1 gets Bye, Number 2 and Number 3 play, Number 4 and Number 5 play. Bye then plays the winner of Number 2 and Number 3, if Number 2 or Number 3 beats Bye team then they get the highest seed and the winner of Number 4 and Number 5 gets the lowest seed. If Bye team wins then the winner of Number 4 and Number 5 get the highest seed.
- F. For basketball, in tie situations of three or more teams, Tuesday "high seed home" district games will be moved to Thursday and the Thursday games will move to Friday. First tiebreaker game will be played on Monday and second tiebreaker game will be played on Tuesday.
- G. When there is no mutual agreement to change a District Playoff site, date or time the contest will be played at the league assigned time. If that is not possible, then a league vote will be needed to approve any changes.

# STANDARD OPERATING PROCEDURES BASEBALL

- 1. <u>Official Rule Book</u>: The National Federation Rule book applies.
- 2. <u>Number of Innings</u>: The baseball games in conference are seven innings, unless the game goes into extra innings or is called because of weather or lack of daylight.
- 3. <u>Speeding Up Games</u>: Ten (10) run rule -- Any team ten (10) runs ahead by the end of five (5) innings, shall be declared the winner of the game. A game called at the end of four and one half (4 1/2) if the home team is ahead or five (5) innings because of weather or lack of daylight shall be considered a complete game.
- 4. <u>Baseball Pitcher Limitations</u>: Follow WIAA pitching limitations and procedures.
- 5. <u>Umpires</u>: Two (2) association umpires are recommended for Varsity conference games.
- 6. <u>Game Ball</u>: The host school shall provide official high school balls.
- 7. Warm-up: Home team shall take infield first ten (10) minutes and shall make the field available to the visiting team at least ten (10) minutes before start of game. Flexibility is permitted if visiting team is ready for infield before home team. For weekday games, whatever facilities and machines that the home team has and uses will be available for the same amount of time for both teams one hour before game time. Neither team may use the batting cages prior to one hour before game time. On Saturdays, there is no restriction on pre-game warm-ups prior to the one hour before game time. Coaches need to communicate upon arrival or earlier about times, logistics, and availability of facilities.
- 8. <u>Protests:</u> Protests will follow WIAA policy.
- 9. <u>Starting Times:</u> All Saturday games will start at 11:00 am. Weekday double headers will start at 3:00 pm. All weekday single games will start at 4:00 pm. Times may be changed by mutual agreement.
- 10. <u>Line-Up Cards:</u> Two cards should be made up; one for the umpire and one for the other team. A team roster with player's full names and numbers should be exchanged at the start of each game.
- 12. <u>Games Called Off:</u> The home team shall call the visiting school as soon as possible if the field is unfit for play. The coach/athletic director of the host school should make the call to the coach/athletic director of the visiting school.
- 13. <u>Make-up Games</u>: It is recommended a called-off game be made up on the earliest available date.

- 14. Suspended Game: In case of a suspended game, the game shall continue from the point of suspension at a later mutually agreed upon time. The line up and batting order of each team will remain exactly the same as the line up and batting order was when the game was suspended, subject to the rules governing the game. Suspended games may be forfeited by league approval.
- 15. <u>Music Systems:</u> Music is not allowed during live play.
- 16. <u>Time between games:</u> Twenty (20) minutes unless mutually agreed upon between coaches
- 17. <u>Courtesy Runner:</u> Courtesy runner is allowed for the pitcher and catcher at any time. A courtesy runner may only run for the same position.
- 18. Reporting: Each school is responsible to report to their own newspapers.
- 19. <u>Sub-Varsity Time Limits:</u> No new inning will begin after 1 hour and 45 minutes of game play.

# STANDARD OPERATING PROCEDURES BASKETBALL

# 1. Starting Times:

- a. Unless mutually agreed upon, JV games will start at 4:30, with a 6:00 start time for the varsity girls' game. Varsity girls' warm ups will not start prior to 5:40 to allow for 15 minute warm up and 5 minute player introductions. Varsity boys' games start 20 minutes (15 minute warmup & 5 minute introductions) after girls' varsity game. The alternate gyms, first game starts at 4:30 and remaining games 15 minutes after completion.
- b. The host school will determine the location of sub-varsity games.
- 2. <u>Visiting Lockers</u>: Visiting team lockers shall be open one hour prior to the start of the first scheduled contest. For additional information, refer to home school guidelines item G.
- 3. <u>Scoring</u>: Scoring will be as described in the National Federation Rule Book.
- 4. <u>Uniforms:</u> All uniform regulations will conform to the state and National rulebooks. Home team wears white uniforms and the visiting team wears dark uniforms unless previous arrangements have been made.
- 5. <u>Program Information</u>: The following information shall be provided to each school two days prior the game. The program must include a team roster in numerical order showing number, name, height, position and year in school. (Use State Guidelines)
- 6. <u>Ball</u>: An official high school basketball will be used.
- 7. <u>Timer and Scorekeeper</u>: Whenever possible, adult help should be used for these positions. For Varsity contests, home and away score keepers shall be seated together at the scorer's table.
- 8. Officials: Officials for the varsity game must be registered. Apprentice officials may be used for the "C" squad and JV game unless an emergency exists in the officials association.
- 9. <u>Game Introductions</u>: The following order will be used: Non Starters from visiting school, Nonstarters from host school, Alternate Visitor-Home starting five. Coaches Visitor-Home, Officials. Team huddles may not take place in center court.
- 10. <u>Sportsmanship</u>: Shake hands after the game and encourage improved sportsmanship.
- 11. Reporting: Each school is responsible to report to their own newspapers.
- 12. Districts: Official state ball to be used at District tournaments.

#### **CHEERLEADING**

#### 1. Host School Rules:

- A. Have a space available for visiting cheerleaders for stretching.
- B. Have a person available to show visiting school where they are to cheer.
- C. Coaches introduce themselves before game begins.
- D. Mascots allowed only at home school events and must stay on own side and uphold all sportsmanlike conduct.

# 2. <u>Visiting School Rules:</u>

A. No mascots may travel to visiting schools in uniform.

# 3. General Guidelines:

- A. Limit of eight cheerleaders at one time standing on sideline during basketball.
- B. Less or more than eight cheerleaders may be on the sideline during a basketball game if the home school Athletic Director deems the gym unsafe. The number of cheerleaders on sidelines is left to the discretion of the Athletic Director. If there are more or less than eight (8) cheerleaders, the host AD must communicate and create an equal opportunity for both teams to have the same number on the court. (First reading edit from 9/19/22)
- C. All WIAA rules are to be followed with no exceptions.
- D. A coach or other school appointed adult representative shall be in attendance and accessible at all events. Coaches need to supervise their squads at all times.
- E. Pom-poms or silent promotions (without writing) of spirit held by the fans are permissible as long as it is not offensive to the opponent.
- F. SIGNS Official school banners, welcome signs, and hand held signs that are positive, directed only toward the school's team, promote good sportsmanship, and do not block the view of the spectators are allowed. Run through signs are not permitted.
- G. Cheerleaders are encouraged to learn crowd control techniques.
- H. Pom-poms should not be left on the floor for storage.
- I. Do not interrupt the opponent's cheers in progress.
- J. Stay back from the playing area to prevent interference with the game/officials.
- K. Cheerleaders must refrain from cheering and stomping on the floor during free throws in basketball.
- L. Cheerleaders should help instruct the student body on what good sportsmanship is.
- M. General rules: NO noisemakers, NO stomping/pounding on bleachers, NO negative activity during player introductions, NO booing of officials/opponents.

#### CROSS COUNTRY

- 1. <u>Teams</u>: Varsity teams will be made up of seven (7) members. A team may qualify as a full team with only five (5) runners.
- 2. <u>Junior Varsity:</u> Junior Varsity will run with Varsity.
- 3. <u>Course Length</u>: Length of course shall not exceed five (5) kilometers (3.1 miles).
- 4. <u>Starting Times</u>: The following start times shall be observed unless changed by mutual consent of teams involved. Girls run first, order will not be changed, girls/boys races will not be combined.
  - A. Weekdays 4:00 pm
  - B. Saturdays 11:00 am
- 5. Scoring and Ties: Scoring and ties will be as described in the National Federation Rule Book.
- 6. <u>Uniforms</u>: All Varsity uniforms will conform to the state and national rulebooks.
- 7. <u>Conference Champion</u>: The conference championship will be determined by head to head team record. If teams meet more than once, the last meeting is the league contest. Refer to YVIAA guidelines for combining or separating league championships.
- 8. <u>Reporting</u>: Each school is responsible to report to their own newspapers.

#### **FOOTBALL**

- 1. <u>Starting Times:</u> The following starting times shall be observed unless changed by mutual consent of teams involved.
  - A. JV and C 5:30 pm
  - B. Varsity -7:00 pm
  - C. Half Times Varsity 15 minutes, JV and C 10 minutes
- 2. <u>Visiting Lockers:</u> Visiting team lockers shall be open by 5:30 pm for a Varsity game and 4:30 for a JV/C game. For additional information, refer to host school guidelines item G. For long trips schools may call ahead to see if a locker room is available.
- 3. <u>Scoring:</u> Scoring will be described in the National Federation Rule Book.
- 4. <u>Videoing:</u> Teams will exchange game video of your last 2 games of the current season (the game you played 2 weeks ago as well as the game you just played) prior to the next scheduled game date. Videoing must be from an elevated position on the side of the field, not the end zone. End zone videoing will be allowed only for teams that are playing in the game, not for teams scouting the game. End zone video will not be used for the video exchange. SCAC Schools must use an electronic film exchange website for video exchange. All video is required to be exchanged by 12:00pm the Saturday prior to the next scheduled game.
- 5. <u>Uniforms:</u> All uniform regulations will conform to the state and national rulebooks. Home teams wear dark colored uniforms and the visiting team wears light colored uniforms.
- 6. <u>Ball:</u> Individual team's choice of ball, if the visiting school wishes to use their own ball, they are responsible to furnish a ball holder/cleaner. During inclement weather, two balls and a ball cleaner are to be furnished by the host school.
- 7. <u>Program Information:</u> A state roster in numerical order showing number, name, weight, position, and year in school will be supplied to the host school by Wednesday preceding the Friday game. (Use State Guidelines)
- 8. <u>Sidelines:</u> The home team is responsible to keep spectators or other unauthorized personnel away from the sidelines. It shall be their responsibility to keep spectators in the stands or behind ropes.
- 9. <u>Scouts:</u> Visiting scouts will be admitted with an appropriate pass. Scouts are to remain in designated spectator areas only.

- 10. <u>Tie Games:</u> JV and C squad games <u>will not</u> go into a tiebreaker. Varsity contests ending in ties will be settled by using the Kansas Tiebreaker according to current WIAA guidelines.
- 11. <u>Officials:</u> Four (4) registered officials are to be requested for Varsity conference games. Schools are to request not less than three officials for each JV and C Squad contests.
- 12. <u>Game Length:</u> Varsity, JV, & C contests will be four (4) twelve minute quarters
- 13. <u>Reporting:</u> Each school is responsible to report to their own newspapers.
- 14. <u>Possible Ties:</u> If tie possibilities exist in determining league standings that require a playoff, the playoff will be a modified Kansas City Tie Breaker (Three Possessions Guaranteed for each team).

The playoff will also be on the Monday immediately following the Week 9 Regular Season game.

If "A" loses, the winner of number 2 is 1<sup>st</sup>. Game number 3: "A" vs. loser of game number 1, winner is 2<sup>nd</sup> and the loser is out.

- 2. If no winner of head to head, then a play-off will take place using the state tiebreaker. Seeding will be determined by the football tie criteria. Number 1 will play number 4 and number 2 will play number 3. Winners qualify for the tournament. Losers play for the remaining tournament spot.

#### FOUR WAY TIE TWO TEAM ELIMINATED

1. Winner of head to head takes the top seed.

2. If no winner of head to head, then a play-off will take place using the modified Kansas City tiebreaker. Seeding will be determined by the football tie criteria. Number 1 will play number 4 and number 2 will play number 3. Winners qualify for the tournament. Losers are eliminated.

# FOUR WAY TIE THREE TEAMS ELIMINATED

- 1. Winner of head to head takes top seed.
- 2. If no winner of head to head, then a play-off will take place using the modified Kansas City tiebreaker. Seeding will be determined by the fall number draw. One will play 4 and 2 will play

#### **GOLF**

# STANDARD OPERATING PROCEDURES

- 1. Rules: USGA/WIAA rules will govern except in cases of local ground rule changes.
- 2. <u>Disputes:</u> The course professional will serve as final arbiter in all questions involving rules. Coaches should be instructed to list the golfers in the order of their ability with the best golfer listed as number one, etc.
  - A. Contestants will keep each other's score within the group. The match official scorer will not accept scorecards unless they are signed by both the individual player and his/her scorer. Penalty for unsigned scorecards is automatic disqualification.
  - B. All putts must be holed out according to USGA rules. Failure to do so will disqualify the player.
  - C. Club throwing shall be a two (2) stroke penalty. Should a second offense occur, the individual would automatically be disqualified from further play.
  - D. On the day of the match, practice is restricted to the putting green and the practice range area only.
  - E. No caddies will be permitted. It is permissible for a player to pull his own golf cart.
  - F. During the match, spectators will be allowed to observe teams or individual players from a distance of seventy-five (75) feet. No coaching from spectators. Spectators will be given one warning. A second violation will result in player disqualification.
- 3. <u>Starting Times and Length of Play:</u> Matches between South Central Athletic Conference teams will use the following starting time. Conference matches will be eighteen (18) holes and start at 1:00pm when possible. The pre-match designated one thru four team members will play sudden death, (total strokes) starting on the first tee. To break team score ties, goes to lowest score of 5<sup>th</sup> golfers, then 6<sup>th</sup> golfers, then sudden death, (total strokes) starting on first tee with two golfers from each team. League will work with individual courses at to date and times of matches. To keep an acceptable pace of play double par is maximum allowable score on any hole. For example once a player reaches a score of 7 on a par 3 hole and has not completed the hole. The player must stop playing the hole and take a 7 for the hole.
- 4. <u>Team Membership:</u> The starting members of each team **(6)** MUST be identified prior to the tee time.
- 5. <u>Contest Winner:</u> Contest winner will be determined by counting the best four out of six scores. Total score of four person team. To be considered a team, there must be at least 4 and not more than 6 members. The best 4 scores will determine the team score. To break team score ties, go to lowest score of 5<sup>th</sup> golfers, then 6<sup>th</sup> golfers, then sudden death, (total strokes) starting on first tee with two golfers chosen by coach from each team.
- 6. <u>Conference Champion</u>: The conference standings will determine the conference champion. Head to Head match-ups will determine conference standings. If teams meet more than once in the

- league schedules, the last time two teams meet will be the match of record for conference standings.
- 7. <u>Sub-District Qualification</u>: All Varsity teams (maximum of 6 golfers) will qualify for sub-district tournament and League schools without enough golfers to field a team for league matches may bring all eligible boys and girls golfers to the district tournament.
- 8. <u>District Qualification:</u> The top half of the varsity boys and girls sub-district fields and ties will qualify for the district tournament.
- 9. <u>Reporting:</u> Each school is responsible to report to their own newspapers.
- 10. <u>Dress Code:</u> For the entire match, participants will wear collared shirts and slacks/hemmed shorts. No denim shorts allowed. Player will be disqualified if dress code is violated at any time during the match.

#### SOCCER

# STANDARD OPERATING PROCEDURES

- 1. Rules: National Federation Rulebook and WIAA handbook will be as follows:
  - A. All games -- Varsity or Junior Varsity will consist of two 40-minute halves with a 10-minute halftime as recommended in the National Federation Rules.
  - B. Coaches Box -- Coaches must remain on the sidelines of the field between the offside lines. The coach may only come onto the field to attend to an injured player or during an unsportsmanlike incident.
  - C. Timing and Scoring -- Official time is kept on the field by the referee and only the score should be kept on the scoreboard.
  - D. Substitutions -- National Federation rules pertaining to substitution will apply.
- 2. <u>Officials</u>: Three registered officials should be used for each match whenever possible.
- 3. <u>Starting Time</u>: Weekday games will start at 4:00 pm or 6:00 pm and Saturday games will start at 11:00 am or 1:00 pm.
- 4. <u>Contest Format</u>: The game will consist of two 40-minute halves.
  - A. Ties Regular season league contests (west vs. west or east vs. east) which are tied at the end of 80 minutes of play will be followed by two (2) five minute sudden death overtime periods. A coin shall be flipped prior to the first overtime period. If the game remains tied at the end of the second overtime period, a shootout will be held which follows the State shootout format.
  - B. Regular season non-league contests which are tied at the end of 80 minutes of play will end in a tie unless mutually agreed upon to play off the tie. If mutually agreed upon to play off the tie, the tie-breaker procedure will be the same as in letter A.
  - C. The interval between the second half and the first overtime period shall be five (5) minutes. The interval between the first overtime period and a second overtime period shall also be five (5) minutes. The overtime periods are sudden death formats; first team to score wins the game.
  - D. All Sub-Varsity soccer contests shall end at the end of regulation time, even if the score is tied.
- 5. Reporting Game Results: Each school is responsible to report to their own newspapers.
- 6. <u>Team Rosters</u>: Both teams must provide 3 team rosters, that include players full name, number, position and year in school, to be exchanged before the game.
- 7. Uniforms: Follow WIAA and National Federation Rules.
- 8. <u>Scoring and League Standings:</u> League standings will be based upon win-loss record. In the event of a tied win-loss record, seeding into the district tournament will be decided by the following tiebreaker procedure:
  - a) Head to Head
  - b) Total Season Points\*

# c) Number Draw

\*If total points are needed to break a tie, the points will be based on the following:

Win in regulation or sudden-death overtime = 3 points

Win in shootout = 2 points

Loss in shootout = 1 point

- 10. There will be East-West leagues for girls and boys soccer and two league championships.
- 11. <u>Equipment:</u> The home team must provide three (3) National Federation approved soccer balls for each conference game.

<sup>\*</sup>No team shall be eliminated from postseason based on points.

# STANDARD OPERATING PROCEDURES

- 1. Official Rules: WIAA and National Federation Rules.
- 2. <u>Make-Up Games:</u> The home team shall call the visiting school as soon as possible if the field is unfit for play. The call should be made by the coach/athletic director of the host school to the coach/athletic director of the visiting school. Any game postponed or rescheduled must be made up as soon as possible.
- 3. <u>Officials:</u> Two (2) association umpires are recommended for Varsity games.
- 4. <u>Game Ball:</u> The host school shall provide official high school softballs.
- 5. <u>Game Length:</u> Contests are scheduled for seven (7) innings.
  - A. 15 run rule after 3 or more innings, and 10-run rule after 5 innings is in effect.
  - B. Tie Breaker Same as state game ending procedures.
- 6. <u>Suspended Game:</u> In case of a suspended game, the game shall continue from the point of suspension at a later, mutually agreed upon time. The line up and batting order of each team will remain exactly the same as the line-up and batting order was when the game was suspended, subject to the rules governing the game.
- 7. <u>Starting Times:</u> All Saturday games will start at 11:00 am. Weekday double headers will start at 3:00 pm. All weekday single games will start at 4:00 pm. Times may be changed by mutual agreement.
- 8. <u>Line-up Cards:</u> Two cards should be made up; one for the umpire and one for the other team. A team roster with player's full names and numbers should be exchanged at the start of each game.
- 9. Reporting: Each school is responsible to report to their own newspapers.

For weekday games, whatever facilities and machines that the home team has and uses will be available for the same amount of time for both teams one hour before game time. Neither team may use the batting cages prior to one hour before game time. On Saturdays, there is no restriction on pre-game warm-ups prior to the one hour before game time. Coaches need to communicate upon arrival or earlier about times, logistics, and availability of facilities. Pitcher and catcher may warm-up in front of their own dugout.

- 13. <u>Conference Champion:</u> The division standings will determine each conference champion. Resolution of ties will be determined by the adopted conference policy for playoffs.
- 14. <u>Speed Up Rule:</u> The speed up rule may be used by either or both teams, but each team must decide prior to the start of each game. The speed up rule allows for a courtesy runner for the pitcher and/or catcher.
- 15. <u>Music Systems:</u> Music is not allowed during live play.
- 16. <u>Time Between Games:</u> Twenty (20) minutes unless mutually agreed upon between coaches.
- 17. Protests: Protests will follow WIAA policy.
- 18. <u>Sub-Varsity Time Limits:</u> No new inning will begin after 1 hour and 45 minutes of game play.

#### **TENNIS**

# STANDARD OPERATING PROCEDURES

- 1. Rules: USTA and WIAA rules will govern play.
- 2. <u>Starting Times:</u> The following starting times will be observed for all conference matches unless mutually agreed upon:
  - A. Single Matches: Weekdays 4:00 pm, Saturdays 11:00 am
  - B. Double Duel Matches: Saturday 10:00 am Scheduled matches canceled due to inclement weather shall be made up at the next playable date.
- 3. <u>Matches:</u> Team matches shall consist of three doubles and two singles, using a minimum of eight different players. Matches will be two out of three sets; 12-point tiebreakers will be used at 6-6 set score. When weather, darkness or time limits interfere, matches may be shortened. By mutual consent of coaches a pro-set may be substituted for a regular match or in lieu of a third set a 12 point tiebreaker may be used at the end of the 2<sup>nd</sup> set. No ad may be used if mutually agreed upon.
- 4. <u>Coaches:</u> No coaching during play other than the ten (10) minute break between the second and third sets, and two minutes between the first and second sets.
- 5. <u>Balls:</u> Home team to provide new balls for all matches; not for third set unless coaches agree that new balls are necessary.
- 6. <u>Lines:</u> Players are to call their own lines. In case of disputes and only at the request of a player, both coaches or an agreed upon designee will monitor play.
- 7. <u>Conference Champion:</u> The conference standings will determine the conference champion.
- 8. <u>Player Break:</u> During conference play and District Tournament play, boys and girls may take a ten minute break between sets two and three.
- 9. <u>Line up Cards:</u> Lineups cards are due 15 minutes prior match start time and lineups are announced 10 minutes prior to match start time. First positions will be filled first, followed by second positions. No forfeiting of earlier positions in order to obtain a favorable matchup.
- 10. <u>Order of Events:</u> "Firsts" play "Firsts" and "Seconds" play "Seconds" etc. with other designated matches to follow at the option of the home team. Visiting team shall be notified in advance if the "Firsts" are not going to be played first during any given match.
- 11. <u>Sportsmanship:</u> The point-penalty system will be used whenever needed. This includes after the match is over and enforced in the next match.

- 12. <u>Reporting:</u> Host school is responsible to report to the local newspaper.
- 13. Sub-District and District Tournament: Entries into the sub-district tournament will be into a 16 man bracket with pig tails as needed to get to 16. Starting with the round of 8, it will be a modified double elimination tournament. Alternate matches at sub districts and districts will be a pro set.
- 14. <u>Seeding for Sub-District</u>:
  - A. Tournament Director will run the meeting.
  - B. The following will be considered in the following order:
    - i. Head to Head
    - ii. Common Opponents
    - iii. Overall Record
    - iv. Previous year's placement (district, regionals, & state)
    - v. Coaches vote if no agreement is reached (One school, one vote)
- 15. <u>Forfeit:</u> Tennis players must be present and announced in order for that team to accept a forfeit.

#### **TRACK**

#### STANDARD OPERATING PROCEDURES

- 1. <u>Rules:</u> WIAA and National Federation rules will apply in conjunction with the following South Central Athletic Conference rules.
  - A. Non-participants or persons displaying inappropriate behavior will be kept away from the finish line areas in all meets.
  - B. Host schools may request visiting teams to provide their own starting blocks. The host school is to contact each school in the meet to remind them to bring starting blocks on the day before the meet.
  - C. Discus, Shot and Javelin safety includes:
    - i. Participants must at all times be under direct supervision.
    - ii. Chasers may be used to return discuses, shots and javelins.
    - iii. Participants are not to throw until given the proper signal by meet officials.
  - D. The double duals will be scored as per federation rules.
  - E. In all conference meets (except pole vault and high jumps) field events will consist of exactly four throws or jumps, and no finals.
  - 2. <u>Officials:</u> The host school is responsible for officials of all conference meets held on their facility.
  - 3. <u>Starting Times:</u> The following starting times will be followed for SCAC meets.
    - A. Regular season start time 3:30 (field events) and 4:00 (running events).
    - B. Sub-District and District start time 3:30 (field events) and 4:30 (running events).
    - C. There will be an admission fee to attend District Track. There will not be an admission fee to attend Sub-District Track.
  - 4. <u>Order of Events:</u> The order of events for all South Central Athletic Conference meets is appended to the end of the track SOP's in a form for reproduction and distribution at official conference meets.
  - 5. <u>Uniforms</u>: Follow NFHS and WIAA Rules regarding uniforms.
  - 6. <u>League Meets:</u> Only league schools will be scored in SCAC league meets. Three place scoring will be used- 5, 3, 1. Relays will be scored 5-0.
  - 7. <u>Conference Champion:</u> The conference champions will be determined by dual meet results during the season. The 'scoring' dual meet will be the last time the schools meet during the league schedule. There will be two conference champions (East and West, Boy and Girl).
  - 8. <u>Sub-District & District Meets:</u> The following regulations will apply to the sub-district and district meet:
    - A. There will be two divisions for sub-districts, East and West.
    - B. Each school may enter an unlimited number of entrants or state qualification standard, per event. One relay team may be entered per school. No additions after initial entries have been made. Entries must be entered by 8:00 pm the day prior to the 1st Sub-District Meet.

- C. Sub-district qualifiers will be seeded into districts by time.
- D. Sub-district managers will list qualifiers for districts as 1st, 2nd, 3rd, 4th, in all events up to the number of participants who qualify. Two alternates will be listed in each event. In the event the first alternate cannot participate, the next available athlete will be contacted.
- E. Starting heights for sub-district high jump and pole vault will be decided at the coaches meeting prior to the meet.
- F. Participating schools may be asked to provide officials to assist in running the Sub-district meet. At the District meet all schools will provide officials/workers. Priority of events when schools sign up will be based on the Spring Number Draw. The host school is responsible for contacting all other schools for signing up for the event coverage. If a school does not reply in a timely manner, they lose the priority spot.
- G. Entries for Sub-District and District Meets will be taken from Athletic.net.
- H. FAT timing will be used at sub-district and district events.
- Lane assignments for all running events, including relays, will be seeded based on best time
  from the current season, listed on athletic.net. Field events will be seeded worst to best based
  on their current season record.
- J. Attempts and Finals- All field event participants (except pole vault and high jump) at the sub-district and district meets will have 3 prelim attempts, seeded by season record marks. At the conclusion of the prelim attempts, the athletes with the top 9 marks will receive 3 finals attempts reseeded by prelim marks, worst to best. The athlete will receive their best mark of the day, from either the prelims or the finals.
- K. Qualifiers for District meet from sub-district will be: Top four times in sprints, hurdles and relays, Top eight in the unlaned (1600 and 3200) running events and field events.
- L. Sub-District and District meets will measure Discus and Javelin to the nearest lesser inch (Always Round Down) and all jumps and shot put to the 1/4 inch.
- M. Pole Vault if the sub district or district Track Meet hosts do not have pole vault, those schools with pole vault will meet at an approved site prior to the sub district or district meet.
- N. Pole Vault 5'0" minimum height (girls) and 6'0" minimum height (boys) to advance to Districts. Pole-Vault at Sub-Districts is not required. In all field events, athletes must communicate with the event judges when checking out. In Pole Vault and High Jump, the bar will be paused at the current height during an athlete's 10-minute check out time. If an athlete does not check out, the bar height will not be paused and at NO time during the meet will the bar be lowered in High Jump or Pole Vault.
- O. Starting Height for High Jump, 3'8" Girls, 4'8" Boys. Pole Vault 4'6" Girls, 5'6" Boys.
- P. If you qualify for an event at the sub-district for the district meet, you are required to participate in that event. Qualified events at the district meet are scratch one, scratch all. Per WIAA Bound for State.
- Q. Relay Entrees Coaches/Schools that qualify relay teams must make any changes to their relay team's 6 members before the start of the District Meet. All changes must be made by the coaches meeting, but should be made as soon as possible. Once the district meet starts, the relay teams are set and cannot be altered.
- R. Implements and Pole Vaulters must be weighed in before the start of the sub-district and district meets. Legal implements will be marked, and those not meeting specifications will be impounded until completion of the meet.

- S. District Scoring- Eight place scoring will be used- 10, 8, 6, 5, 4, 3, 2, 1.
- 9. <u>Pass Throughs:</u> A contestant who is injured and unable to compete in a sub-district meet may petition for direct entry into the District meet, provided all of the following conditions are met:
  - A. A written petition signed by the principal is in the hands of the League Secretary 3 days prior to the meet
  - B. The contestant's season record as attested to by the principal is clearly of District-level quality.
  - C. A doctor's statement accompanies the petition stating that the contestant should not compete in the sub-district meet.
  - D. The placement of the contestant in the district meet would not cause the displacement of any contestant who qualified through the sub-district meet. (This generally means that direct entries will not be allowed in the lane events unless there is an open or extra lane.
  - E. The student may participate in an individual event in the District Meet even though the athlete did not qualify in the sub-district meet if the YVIAA Executive Board, or the delegated committee involved give consent, providing that the student has been a member of the school's athletic squad and has been included on a school's eligibility list for at least 50% of the regular season.
- 10. <u>Games Committee:</u> (3 to 5 adults knowledgeable in track from different schools, neutral to the situation) will be appointed by the meet manager to assist him as needed and to resolve all disputes and protests. DECISIONS BY THE GAMES COMMITTEE ARE FINAL, and may not be appealed, except where it can be shown that the committee's decision violated or ignored a WIAA or National Federation rule. Protests/Appeals should be made by head coach in writing and must include the competitor's name, school, event involved, and specific rule in question along with a brief description of what is being protested. Protest form is located at the end of this SCAC SOP Handbook.
- 11. <u>Rules on Relay Team Members:</u> The WIAA rule on relay team membership is as follows: Schools may list 4, 5, or 6 members for each relay team, and only these can run, but any 4 are eligible for each race. Schools should always list more than 4 because, unless you have done so, a last minute injury to one relay member would mean your team could not compete. District qualifying relay team members must be submitted to the district meet manager prior to the district meet. Last changes to relay entries must be made at the District Meet coaches meeting.
- 13. Reporting: Host school is responsible to post results to athletic.net.

#### VOLLEYBALL

#### STANDARD OPERATING PROCEDURES

- 1. <u>Starting Times:</u> The following starting times shall be observed unless changed by mutual consent of teams involved. Weekday matches JV/C 5:30 pm; V 6:30. If no JV, varsity game will be at 6:00 or at a time that is mutually agreed upon by both schools. Saturday matches will be JV/C at 11:00 am; V 12:00 pm
- 2. <u>Visiting Lockers:</u> Visiting team lockers shall be open one hour prior to the start of the first scheduled contest. For additional information, refer to host school guidelines item G.
- 3. <u>Scoring:</u> Scoring will be as described in the National Federation Rule Book.
- 4. <u>Uniforms</u>: All uniform regulations will conform to the state and National rulebooks.
- 5. Play-off/Ties: The following Tie Breakers will be used.
  - i. Head to head matches first, followed by sets
     Example- Two teams split in the regular season. Team A loses 2-3, and then wins 3-1.
     Team A has 5 sets, Team B has 4 sets so team A wins the ties breaker.
  - ii. Win/Loss record against playoff teams (excluding pig-tail matches)
  - iii. Number Draw
- 6. <u>Rules</u>: WIAA approved Standard Operating Procedures will be followed. The following South Central Athletic Conference rules will also apply to all conference contests.
  - A. Player substitution same as state.
  - B. All members of the bench may participate during a time out.
  - C. Warm ups: Follow WIAA warm-up procedures as listed in the Bound for State Volleyball Regulations.
- 7. <u>Games:</u> Varsity will play 3 out of 5 matches. JV and C squad matches will be 3 out of 3, with the third game being to 25 points, or if a team doesn't have a C team then schools can mutually agree to play 5 out of 5 with one of the sets played to 15 points.
- 8. <u>Officials</u>: Two (2) rated officials should be used for each Varsity match. At least one official must be certified by the WOA if two are not available. Home school will provide line judges. Varsity line judges should be adults whenever possible.
  - -For postseason play, WOA officials will be used as line judges whenever possible.
- 9. <u>Ball:</u> Official balls will be used in all matches.
- 10. <u>Reporting:</u> Each school is responsible to report to their own newspapers.

- 11. <u>Program Information:</u> A roster in numerical order showing *in order:* number, name, position, and year in school will be supplied to the host school at least two days preceding game day. (Use State Guidelines)
- 12. <u>District Tournament</u> First round games will be played at the high seed home site. Officials will be from the home site's association. All other games will be at a predetermined location.
- 13. <u>Warm-up Balls</u>: The home team shall provide a minimum of 12 balls per court for use by both the home and visiting team. Recommended to use both 12 ball baskets for Varsity warm ups or as many as possible.

#### **WRESTLING**

#### STANDARD OPERATING PROCEDURES

- 1. <u>Rules</u>: WIAA and National Federation rules will apply for all wrestling contests in the South Central Athletic Conference.
- 2. <u>Officials</u>: Both the timer and scorekeeper should be adults whenever possible. Registered officials must be used for all conference matches.
- 3. <u>Starting times</u>: The following starting times will be observed for all varsity conference matches: JV matches may be before or after Varsity matches. 7:00pm start times for duals if mutually agreed.
  - A. Weekdays Double Dual meets 6:00 pm
  - B. Weekdays Dual meets 6:00 pm
  - C. Weekdays Crossovers 5:00 pm
- 4. <u>3-Way Matches</u>: All teams will weigh in together. Team that travels the furthest wrestles first so they can return home earlier.
- 5. Seeding for District:
  - A. The Tournament Director will run the meeting.
  - B. The following will be considered in the following order:
    - Head to Head
    - ii. CommonOpponents
    - iii. Previous year's placement (district, regionals, & state)
    - iv Overall Record
    - v. Coaches vote if no agreement is reached (One school, one vote)
- 6. <u>Program Information</u>: Host coach's responsibility to contact the visiting team the day before the match. A roster in weight order showing name, weight, and year in school will be supplied to host school the day preceding the match. Send WIAA Rosters/Weight Management Sheet. Introduction of wrestlers will be equal for all teams.
- 7. <u>JV Matches</u>: Coaches call ahead.
- 8. Reporting: Each school is responsible to report to their own newspapers.
- 9. <u>Handshake</u>: Wrestlers will shake hands during face-offs. Wrestlers may shake hands with opposing coaches following their individual match. Teams will line up and "slap hands" following completion of all matches.
- 10. Weighing In: All teams weigh in together following NFHS weigh in guidelines.
- 11. WIAA State weight management guidelines will be followed

#### **SPORTSMANSHIP**

#### 1. The Fans:

- A. Recommended parent night for each sport season. One of the items covered would be spectator etiquette.
- B. Spectator information may be shared at an event through the following options:
  - i. PA system
  - ii. Handouts
  - iii. Information included in programs
- C. Game introductions are to be equal for both teams.
- D. Encourage coaches not to incite fans.
- E. Instruct the student body on what good sportsmanship is.
- F. General rules: NO noisemakers, NO stomping/pounding on bleachers, NO negative activity during player introductions, NO booing of officials/opponents.
- G. Continuous standing at indoor events will only be allowed in designated areas.
- H. Throwing of any objects into the playing area is not permitted.
- I. Negative, derogatory or discriminatory cheers or language is not permitted.
- J. Signs Official school banners, welcome signs, and wall banners approved by the host school that are positive, directed only toward the school's team, promote good sportsmanship, and do not block the view of the spectators are allowed. Run through signs are not permitted.
- K. Only uniformed cheer leaders may use megaphones.

#### 2. The Teams:

- A. Coaches will coach proper attitude/behavior toward opponents and officials.
- B. Coaches will discipline/temporarily remove players from contests who display poor sportsmanship.
- C. Have a pre-game handshake/fist bump during introductions.
- D. Have a post-game hand slap/fist bump, immediately following the game.
- E. All non-spontaneous celebrations and/or post-game rituals will not be held at center court or mid-field. Coaches will, in a timely manner, direct their teams to the appropriate sideline/locker room after the post-game hand slap.
- F. Recommend pre/post game social interaction.

#### 3. The Bands

- A. Play only at home contests. May be used in postseason away sites.
- B. Play the National Anthem before a varsity contest.
- C. No playing during free throws.
- D. Instruments are not to be used as noisemakers.
- E. Play at breaks/time-outs only, all music is to end when play resumes.
- F. Volume should be at a safe level for amplified instruments.

## **INCLEMENT WEATHER POLICY**

All events past league play shall follow the WIAA's Inclement Weather Policy.
